This End User License Agreement, including any supplemental terms (collectively, The "EULA") is between you (an individual, company, or any other entity) and Beary Type Studio and governs the usage of Beary Type Studio's product.

### **Your Not Allowed To:**

#### **1. Sell and Redistribute**

The items purchased are for your use only. You cannot sell and redistribute it to any third party.

#### **2. More User**

Allowing more than one user to use items downloaded/purchased from us.

#### **3. Convert**

Converting products into different formats without written permission from us

#### **4. Duplicate**

You may not duplicate/copy the product to anyone without our permission.



## **Preamble**

## **End user license agreement**

This license agreement is a legally binding contract between you, the licensee, and BearyType Studio. By downloading, installing, and/or using this font software, you acknowledge that you have read, understood, and agreed to the terms of this license agreement. If you do not accept these terms, please refrain from completing the purchase transaction or installing the font.

### **1. License & Usage rights**

Upon downloading the font, you are granted a non-exclusive and non-transferable right to use the font software on your computers according to the license terms. By default, each BearyType Studio license restricts the number of workstations (CPUs) where the font can be installed, regardless of location. The number of output devices (e.g., laser, color, or inkjet printers) is not restricted, provided these devices do not store the font software permanently.

### **2.1. Copyright**

The typeface design and font software — including all updates, expansions, modified versions, and working copies — are the intellectual property of and are owned by BearyType Studio (Dian Haniffan Hadi). You agree that the typeface design and font software are protected by international copyright, design patent, and trademark laws. All rights are reserved unless expressly granted in this agreement. For personal use and within the conditions outlined in this agreement, you are permitted to make a backup copy of the font software, documentation, and license agreement. However, you are not authorized to distribute the font software in any form, whether by selling, lending, donating, or otherwise.



## **2.2. No Transfer of Rights.**

You shall not sell, lease, sublicense, permit use of, or otherwise assign or transfer any of your rights, duties, or obligations under this agreement, in whole or in part, to any person or entity. Without limiting the foregoing, typefaces licensed for use by a specific publication may not be transferred to or used by other publications owned or managed by a common corporate parent and/or affiliated with the specific publication to which this license was granted, unless an additional license is purchased from BearyType Studio. Any transfer of the license granted to you requires written permission from BearyType Studio. Upon transferring your license, you must delete the font software and all copies of it.

## **3. Printing**

We recommend providing your service bureau with a workflow PDF file that has the font software embedded.

### **4.1. Embedding in Workflow PDFs**

BearyType Studio grants you a limited license to embed the font in embedded documents in PDF format ("Workflow PDFs"). Additionally, BearyType Studio grants you the right to distribute these PDF documents on the World Wide Web.

### **4.2. Embedding in Flash Files**

BearyType Studio grants you a limited license to create and distribute embedded documents in SWF format ("Flash Files"), including the free font.

### **4.3. Embedding in commercial products**

BearyType Studio grants you a limited license to embed the font software in commercial products (e.g., eBooks, games, DVDs, or other software).



#### **4.4 Embedding for web**

You may use the font software on websites at any time and on any website. You are allowed to use the font software for web font linking via @font-face. #### **6.1. Infringement Indemnification**

## **7. Warranty and limitation of liability**

BearyType Studio has taken all necessary steps to produce high-quality OpenType fonts. The minimum system requirement is Mac OSX or Windows 7/Vista/XP/2000. Please note that not all systems or applications support OpenType features and kerning equally well. If you encounter any difficulties with our font software, please contact us, and we will do our best to resolve any issues. If this is not possible, we will be pleased to refund your money, which shall be the limit of our liability in this transaction. Except for this warranty, there is no warranty for performance or results obtained by using the font software. BearyType Studio will not be liable for any damages, claims, or costs of any kind, including direct, indirect, special, incidental, or consequential damages, business interruptions, or for lost profits, savings, or business information, arising out of any use of, or inability to use, the font software.

## **8. Final provisions**
